

Requirements for Safe Church, Safe Community Modules

Each church and entity is responsible for ensuring compliance regarding Safe Church certification and clearances, as well as maintaining these records. Certification can be completed **online** or **in person**. Each individual module is roughly 10-25 minutes long. Training must be completed every **3** years. All clergy should send their transcripts to safechurch@diocesecpa.org. All other individuals should send their transcripts to their individual church or school office.
